**FIRST AND FINAL APPLICATION FOR FEES AND EXPENSES
OF EDWARDS ANGELL PALMER & DODGE LLP**

The law firm of Edwards Angell Palmer & Dodge LLP, f/k/a Edwards & Angell, LLP ("EAPD"), hereby moves the Court for an order awarding EAPD compensation in the amount of \$45,953.75 for services rendered and \$3,764.47 reimbursement for expenses incurred, both during the period August 23, 1990 through August 29, 1991, in representing John F. Cullen, the Chapter 11 Trustee (the "Trustee") of Debtor. As grounds therefor, EAPD states as follows:

1. EAPD was appointed as counsel to the Trustee by Margin Order of U.S. Bankruptcy Judge Arthur N. Votolato dated September 20, 1990 (a copy of Trustee's Application to Employ EAPD and said Margin Order is attached hereto as Exhibit A).

2. The personnel of EAPD whose services are covered by this Application are as follows:

(a) Edward J. Bertozzi, Jr. ("Bertozzi"), partner, hourly rate: \$190 to \$210 during the relevant period; admitted to practice in Rhode Island in 1967 and in the U.S. District Court (D.R.I.) in 1971, has specialized in bankruptcies, receiverships, and insolvency proceedings for over 25 years.

(b) Theodore MocarSKI ("MocarSKI"), associate, hourly rate, approximately \$125; date admitted to practice in Rhode Island unknown; researched redemption, consignment and constructive trust issues.

(c) Andrea Corcoran ("Corcoran"), associate, hourly rate, approximately \$125; admitted to practice in Rhode Island in 1990; member of EAPD litigation department; worked on litigation matters, including discovery, appeals and drafting pleadings.

(d) Gayle Ehrlich ("Ehrlich") associate, hourly rate, approximately \$135; admitted to practice in Rhode Island in 1986, in Massachusetts in 1985; an experienced bankruptcy associate.

3. On November 8, 1989, an involuntary bankruptcy petition was filed against Debtor. On December 6, 1989, Debtor filed a Notice of Voluntary Conversion to Chapter 11. On August 10, 1990, over Debtor's objection, this Court entered an order granting the motion of the U.S. Trustee for the appointment of a Chapter 11 Trustee of Debtor. The Certificate of Appointment of John F. Cullen as Chapter 11 Trustee was filed on August 16, 1990. The Trustee engaged Bertozzi and EAPD as Trustee's legal counsel on August 23, 1990, filed Trustee's Application to Retain Bertozzi and EAPD as legal counsel on August 23, 1990, and said application was granted by Order of this Court dated September 19, 1990.

4. The services rendered by Bertozzi and EAPD to the Trustee included primarily the following:

(a) assisting the Trustee in obtaining possession of Debtor's assets and records, and information with respect to the Debtor and Debtor's operations.

(b) analyzing and evaluating the claims and liens of secured creditors, primarily Eastland Bank and Peoples Bank, and negotiating and litigating with respect thereto;

(c) analyzing and evaluating the claims of so-called redemption coin claimants and taking action with respect thereto;

(d) negotiating and obtaining a financing order with Eastland Bank to fund the Trustee's activities in securing and liquidating Debtor's assets;

(e) assisting the Trustee in analyzing and evaluating the appropriate methods of liquidating Debtor's assets;

(f) performing the above services in the face of continuous and strong opposition by Debtor, directed by its principal, Harold Chorney.

5. Attached hereto as Exhibit B are copies of EAPD bills which itemize all the services rendered by EAPD with respect to which compensation is sought.

6. Attached hereto as Exhibit C is a fee application summary sheet (R.I. Bankr. Form C.2) and as Exhibit D a final fee allowance summary (R.I. Bankr. Form C.4).

7. EAPD has received no retainer in this case. The present Application is EAPD's first and final application in this case for fees and expenses.

8. EAPD is not seeking payment for \$35,921.36 in fees for services rendered to the Trustee during the period August 30, 1991 through December 22, 1993 because, due to a glitch in transferring data to a new computer, EAPD cannot recover the data as to individual time entries for that period, although the computer does show the data to the aggregate amount of fees for said period.

WHEREFORE EAPD respectfully requests that the Court enter an order (a) awarding EAPD compensation in the amount of \$45,953.75 for services rendered and (b) \$3,764.47 reimbursement for expenses incurred, both during the period August 23, 1990 through August 29, 1991, in representing the Trustee.

APPLICATION TO APPOINT ATTORNEY FOR THE CHAPTER 11 TRUSTEE
