

Now comes Harold F. Chorney, pro se, a petitioner with property interests and an interested party in the above captioned matter and requests the court review material presented concerning fees of professionals and other matters, including the First and Final Application for Fees and Expenses of Edwards Angell Palmer & Dodge LLP.

Petitioner states that Harold F. Chorney has raised new, valid and previously undecided issues in his Offer of Proof Concerning Standing.

3. There is no doubt that Pre-Columbian golden frog amulets of great value and possibly other items of value, personal items belonging to Harold F. Chorney, are missing.


